Assessment against the SafetyMAP OHS Criteria

Option 3:

Certification to OHSAS: 18001 (International Option)

The Occupational Health and Safety Assessment Series (OHSAS) Specification provides this option. It is referred to as OHSAS 18001, and has been developed to be compatible with the Environmental Management Systems Standards (ISO 14001) and the Quality Management Systems Standard ISO 9001
